

RESOLUTION OF APPRECIATION

The Republican River Water Conservation District sitting at its Regular Quarterly Meeting in Wray, Colorado this 16th day of November 2021 does unanimously adopt and publish this resolution of appreciation for one of members of the District's Board of Directors, Brent Deterding, and in doing so does find and resolve as follows:

WHEREAS, Brent Deterding possesses an admirable strength of will, unflinching integrity and a constant initiative to solve problems; and

WHEREAS, Brent Deterding has been and continues to be a pillar of his community and his family; and

WHEREAS, Brent Deterding has long been a highly successful agricultural producer in Yuma County, Colorado; and

WHEREAS, Brent Deterding, because of his leadership on the issues of ground water management, was appointed to the Board of Directors of the Republican River Water Conservation District in 2012, representing the Central Yuma Ground Water Management District; and

WHEREAS, as a member of the Board of Directors Brent Deterding utilized his organizational skills, his significant leadership ability, and his belief that all of the agricultural producers in the Basin were in it together to achieve and maintain Compact compliance through the initiation of conservation efforts and the construction and operation of the Compact Compliance Pipeline; and

WHEREAS, Director Deterding accepted the responsibility to explain to the Basin's producers that they could not shirk their duty to comply with the Republican River Compact; and

WHEREAS, Director Deterding worked tirelessly to promote the conservation of groundwater within the District; and

WHEREAS, Director Deterding also worked tirelessly on the acquisition of surface water rights from willing sellers to assist in accomplishing the District's goals; and,

WHEREAS, throughout all these efforts and throughout his tenure as a member of the Board of Directors, Director Deterding attended the meetings of the District Board, the Budget Committee, Negotiating Committee, and the Legislative Committee as well as the meetings of the Republican River Compact Administration; and

WHEREAS, Director Deterding has provided a model of leadership and positive achievement for all the residents of the Republican River Basin; and

WHEREAS, without his dedication the current success of the Republican River Conservation District would have been in doubt.
